- Baiteshwor Rural Municipality has received a grant from Nepal Telecommunication Authority towards
 the cost of Supply, Delivery, Installation, Commissioning and Testing of broadband Internet
 services in designated locations of Rural Municipality, Ward Offices, Health post, Community
 Health Center and Community schools of Baiteshwor Rural Municipality and intends to apply
 part of the funds to cover eligible payments under the contract for
 BRM/NCB/Goods/Dolakha/002/078/79. Bidding is open to all eligible bidders.
- 2. Baiteshwor Rural Municipality, Dolakha invites electronic bids from Nepalese eligible bidders for the procurement of Supply, Delivery, Installation, Commissioning and Testing of broadband Internet services in designated locations of Rural Municipality, Ward Offices, Health post, Community Health Center and Community schools of Baiteshwor Rural Municipality Through 12-Core Optical Fiber under National Competitive Bidding procedures specified in public procurement act and regulations. The estimated amount for the works is NRs. 40,78,926.0 inclusive VAT.

- 3. A complete set of bidding document may be downloaded from PPMO's web site www.bolpatra.gov.np/egp. Bidders should submit their bid electronically and deposit NRs .3000(Three thousand only) for purchasing bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 4. Pre-bid meeting shall not be held.
- 5. Electronic bids must be submitted to the office *Baiteshwor Rural Municipality*, *Pandudanda*, *Dolakha* through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 25th *March* 2022. Bids received after this deadline will be rejected.
- 6. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 25th March 2022 at the office of Baiteshwor Rural Municipality, Pandudanda, Dolakha. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by a bid security, amounting to a minimum of NRs. 1,00,000(One Lakh Only) which shall be valid for minimum 30 days beyond the validity period of the bid (i.e 120 Days).
- 7. If a bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Dharauti Account No.05700074CA at Prime Commercial Bank, Mainapokhari, Dolakha in the



account of Office of the Baiteshwor Rural Municipality Executive, Padudanda, Dolakha and the receipt of the deposited amount of cash should be submitted along with the bid.

- 8. If the last date submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
